- Copies of Previous Year Tax Return

- Personal Information:
  - o For Tax payer, Spouse, & Dependents
    - Social Security numbers, Dates of births, Health Insurance Coverage (Full year, Half Year, no coverage)
      - If Obama Care applies, taxes cannot be filed until form 1095-A is received
      - If no coverage, expect a penalty for each dependent (if any) plus self
